



Standard Product Warranty

COMMERCIAL EQUIPMENT

GENERAL LIMITED WARRANTY STATEMENT

Carrier Corporation (hereinafter "Carrier" or "Company") warrants this product against failure due to defect in materials or workmanship under normal use and maintenance as follows. All warranty periods begin on the date of initial operation (start-up) or 6 months from the date of shipment, whichever is earlier. If a part fails due to a defect in workmanship during the applicable warranty period, the Company will either repair or replace the part with a new or remanufactured part, at the Company's option, at no charge for the part. If the unit has an applicable labor warranty, all labor to repair or replace the defective part will also be included at no cost. Alternatively, and at its option, the Company will allow a credit in the amount of the then factory selling price for a new equivalent part toward the retail purchase price of a new Company product. Except as otherwise stated herein, those are Company's exclusive obligations under this warranty for a product failure. This limited warranty is subject to all provisions, conditions, limitations and exclusions listed below and on the reverse of this document.

PERIODS AND SCOPE OF COVERAGE

ONE YEAR LIMITED WARRANTY (US AND CANADA ONLY) — The Carrier warranty on the below equipment is governed by the terms and conditions on the sales document with Carrier. Standard warranty includes parts only. Labor is also included during the standard warranty period for equipment model numbers beginning with 16, 17, 18, 19, 23, 30HX, 30MP, 30XA, 30XV, 30XW, 30RA, 30RB or 30RC. All first year warranty labor must be performed by Carrier Commercial Service. Products other than those listed above may include first year labor coverage if the option was expressly included in the sale of the equipment.

GENERAL CONDITIONS

1. This warranty is to the original purchasing end user and is not assignable.
2. Installation, use, care and maintenance must be normal and in accordance with instructions contained in the Installation Instructions, Owner's Manual and Company's service information.
3. Carrier reserves the right to require the return, transportation charges prepaid by customer, of any and all parts or components claimed to be defective.

LIMITATIONS OF WARRANTIES: ALL IMPLIED WARRANTIES AND/OR CONDITIONS (INCLUDING IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR USE OR PURPOSE) ARE LIMITED TO THE DURATION OF THIS LIMITED WARRANTY. SOME STATES OR PROVINCES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY OR CONDITION LASTS, SO THE ABOVE MAY NOT APPLY TO YOU. THE EXPRESS WARRANTIES MADE IN THIS WARRANTY ARE EXCLUSIVE AND MAY NOT BE ALTERED, ENLARGED, OR CHANGED BY ANY DISTRIBUTOR, DEALER, OR OTHER PERSON, WHATSOEVER.

THIS WARRANTY DOES NOT COVER:

1. Labor or other costs incurred for diagnosing, repairing, removing, installing, shipping, servicing or handling of either defective parts, or replacement parts, or new units unless a Parts and Labor extended warranty contract is purchased with the chiller.
2. Any product purchased over the Internet.
3. Normal maintenance as outlined in the installation and servicing instructions or Owner's Manual, including filter cleaning and/or replacement and lubrication.
4. Failure, damage or repairs due to faulty installation, misapplication, abuse, improper servicing, unauthorized alteration or improper operation.
5. Failure to start due to voltage conditions, blown fuses, open circuit breakers, or damages due to the inadequacy or interruption of electrical service.
6. Failure or damage due to floods, winds, fires, lightning, accidents, corrosive environments (rust, etc.) or other conditions beyond the control of Company.
7. Damage due to freezing of water, inadequate or interrupted water supply, inadequate water quality, use of corrosive water or rearrangement of plumbing system.
8. Parts not supplied or designated by Company, or damages resulting from their use.
9. Products installed outside the U.S.A. or its territories and Canada. However, Company does provide a standard one year parts only warranty for equipment model numbers beginning with 16, 17, 18, 19, 23, 30HX, 30MP, 30XA, 30XW, 30RA, 30RB or 30RC installed in Mexico, Puerto Rico, Central America or South America.
10. Electricity or fuel costs, or increases in electricity or fuel costs from any reason whatsoever, including additional or unusual use of supplemental electric heat.
11. Any cost to replace, refill or dispose of refrigerant, including the cost of refrigerant. For 19 and 23-series chillers (US and CANADA only), a five (5) year refrigerant warranty is standard and a separate certificate with the details of this warranty is available for review.
12. **ANY SPECIAL, INDIRECT OR CONSEQUENTIAL PROPERTY OR COMMERCIAL DAMAGE OF ANY NATURE WHATSOEVER.**

Some states or provinces do not allow the exclusion of incidental or consequential damages, so the above limitation may not apply to you.
