#### ONE-YEAR YEAR LIMITED WARRANTY.

CAC/BDP (hereinafter referred to as "Company") warrants this product to be free from defects in material and workmanship. If a defect is found within one year from date of original installation of product (whether or not actual use begins on that date), Company will provide a new or remanufactured part, at Company's sole option, to replace any defective part, without charge for the part itself.

#### THREE YEAR LIMITED WARRANTY ON WATER BOILER CIRCULATOR PUMP ONLY.

If a defect is found in the water boiler circulator pump within three years from the date of original a detect is obtained and the weat bolic bo for the part itself.

#### III. FIVE YEAR LIMITED WARRANTY ON ELECTRIC VENT DAMPER ONLY.

If a defect is found in the electric vent damper within five years from the date of original installation of product, Company will provide a new or remanufactured electric vent damper, at the Company's sole option, to replace any defective electric vent damper, without charge for the part itself.

#### THREE YEAR LIMITED WARRANTY ON OIL BURNER ONLY.

If a defect is found in the oil burner within three years from the date of original installation of product, Company will provide a new or remanufactured oil burner, at the Company's sole option, to replace any defective oil burner, without charge for the part itself.

## V. ADDITIONAL LIMITED WARRANTY FOR GAS-FIRED WATER BOILERS (MODEL NUMBERS BW1, BW2, BW3, BW4, BW5) ONLY: TWENTY YEAR LIMITED WARRANTY ON WATER BOILER SECTION ASSEMBLY ONLY.

If a defect is found in the water boiler section assembly within twenty years from the date of original installation of product, Company will provide a new or remanufactured water boiler section assembly, at the Company's sole option, to replace any defective water boiler section assembly, without charge for the part itself. This warranty only applies to the following gas-fired water boilers: Models BW1, BW2, BW3, BW4, and BW5.

#### VI. ADDITIONAL LIMITED WARRANTY FOR GAS-FIRED WATER BOILERS (MODEL NUMBER BW9) ONLY: FIFTEEN YEAR LIMITED WARRANTY ON WATER BOILER SECTION ASSEMBLY ONIÝ.

If a defect is found in the water boiler section assembly within fifteen years from the date of original installation of product, Company will provide a new or remanufactured water boiler section assembly, at the Company's sole option, to replace any defective water boiler section assembly, without charge for the part itself. This warranty only applies to the following gas-fired water boilers: Model BW9.

#### VII. ADDITIONAL LIMITED WARRANTY FOR STEAM BOILERS (MODEL NUMBER BS1.BS2) ONLY: TWELVE YEAR LIMITED WARRANTY ON STEAM BOILER'SECTION ASSEMBLY ONLY.

If a defect is found in the factory-installed steam boiler section assembly within twelve years from the date of original installation of product, Company will provide a new or remanufactured steam boiler section assembly, at the Company's sole option, to replace any defective steam boiler section assembly, without charge for the part itself. This warranty only applies to the following steam boilers: Models BS1 and BS2.

VIII. None of these warranties include labor or other costs incurred for diagnosing, repairing, removing, installing, shipping, servicing or handling of either defective parts or replacement parts.
