Select the appropriate branded website and click on the Registration link to begin the registration. All branded websites function the same and will show the ICP Logo. This Job Aid is specifically shows how to register HVAC equipment.

You can also enter the following address to register ICP equipment: productregistration.icpusa. com

The Home Page for the Registration site will be the same for all brands.

1. Dealers select **I'm a** dealer.

- 10. Enter the **Installation Date**.
- 11. Select the **Brand** from the dropdown. <u>Note</u>: Add all the serial numbers needing to be registered. If you have more than 3 serial numbers, clicking tab after selecting the "3rd" brand will provide additional row(s) as needed.
- 12.Select appropriate Type of Purchase and appropriate Application Type.
- 13. Enter the EQUIPMENT OWNER information
- 14. Review and "<u>Check</u>" the appropriate boxes for the 3 statements provided.

- 19. The **Equipment Owner** will be provided with a **Confirmation Number**.
- 20. In this section, Equipment Owner, Equipment Location, Dealer Information, Type of purchase and Application Type will be listed.
- 21. In the **Installed Products**, all Serial Numbers, etc., will be displayed here. <u>Note</u>: **Coverage** and **End Date** may not be displayed here until the next business day (see yellow highlighted section.)
- 22. You can **PRINT** the **Confirmation** if needed.
- 23. If you have more equipment to register for other customers, you can select "<u>Register</u> <u>another unit</u>?" link and this will keep your dealer information for the next registration.
- 24. Clicking <u>Home</u> link will take you the first page of the Registration Process (<u>note</u>: you would need to re-enter your Dealer information).
